### **Executive Doctor of Philosophy (ePhD) Options**

CIU has created a new Executive Doctor of Philosophy (ePhD) degree program that allows students to waive the dissertation option and take the Research Project/Capstone Option. Students who would like to take the dissertation option are encouraged to do so if they choose to. However, CIU has found other routes that would give students the opportunity to earn an Executive Doctor of Philosophy (PhD) without a dissertation option. This allows the student to achieve their goals in earning an accredited Executive Doctor of Philosophy (ePhD) degree in their chosen specialization.

# **Dissertation Option**

Students who would like to take the dissertation option are encouraged to do so if they choose to.

## **Research Project/Capstone Option**

The Research Project/Capstone Option gives the student the opportunity to complete a research project of their choice. The Research Project/Capstone Option allows the student to choose a topic of their choice, and create a practical research proposal with a minimum of 20 pages and consist of the following:

- Title Page
- ♣ Abstract
- Table of Contents
- ♣ Research of the Study
- Appendices
- References

#### **Capstone Option**

Students will be able to complete a 200 multiple choice examination in their specialized degree of study. The examination will be timed for 2 hours. In addition, students must successfully pass with 80% (B). If the student fails the Capstone Examination, then the student will have the option to retake the examination. The student will only receive three chances to pass the Capstone Examination.

	The IRB is charged with the responsibility of reviewing, prior to its initiation, all research (whether funded or not) involving human participants. The IRB is concerned with protecting the welfare, rights, and privacy of human subjects. The IRB has the authority to approve, exempt, disapprove, monitor, and require modifications in all research activities that fall within its jurisdiction as specified by both the federal regulations and institutional policy.
	The IRB shall have at least five members of varying backgrounds in order to provide complete and adequate review of human research and its institutional, legal, scientific, and social implications. The Board will also include at least one member who is not affiliated with the institution and one member who is not a scientist. The IRB

	has several consultants who advise the Board and are periodically involved in protocol review.
